Thank you all for your great generosity during the December meeting for all the food you brought. After we got there, I found out that Parkway Hills Baptist Church really needs the very large size cans of food as they cook there, then take the food out to the homeless on the streets. So we took the food collected to God's Food Pantry who was very grateful for the donation from the guild. I later asked the executive board to approve a \$150.00 donation to Parkway for their food needs. It passed and we mailed them a check.

At the January meeting, I'll ask for a nominating committee to come forward to prepare the slate of new officers for the new fiscal year. (Time really flies when you're having fun.) Several of us plan to stay in our positions, if the membership approves. But we will have several positions needing to be filled in both the executive board and committee chairs. For example, Shirley Weaver has been the assistant treasurer this year. She will replace Joan Wilson as the nominee for the next term. Please be thinking of the job you would like to know more about and how you can contribute to the guild.

President Donna Petrick called the general meeting of the Quilter's Guild of Plano to order at 7:05 p.m. Members were asked to quietly go to the food tables and fill a plate at any time during the meeting. Sherry Worley explained that samples from the *Cotton Belles Cookbook 2007* were being offered as examples of recipes available on a CD that was available for purchase. Karen Hawkins moved to approve the minutes of November meeting as written in the guild newsletter, seconded by Sheri Smith. The motion passed unanimously. The treasurer's report as written in the newsletter was approved in the same vocal vote manner with a motion by Debbie Skorepa and a second by Aggie Maszaros.

**Old Business:** There was no old business to discuss.

**New Business:** The next board meeting will be January 5<sup>th</sup> at Haggard Library on Coit starting exactly at 7:00 p.m. The next general meeting will be on January 8<sup>th</sup>. A grand thank you was expressed for all the canned food that the membership donated. Parkway Hills Baptist Church makes the food for the needy "in house" and only uses the very large cans. Therefore, the food will all be taken to another church that has a food pantry. All of the money collected will be given to this church. We need responses back on questions and requests that are made in the newsletter. Quilts from the 10<sup>th</sup> and 15<sup>th</sup> guild anniversaries were on display. We do not have quilts made for the 20<sup>th</sup> and 25<sup>th</sup> anniversary. We need to make commemorative quilts. Donna issued a challenge for this to be done. Anniversary pins are available for those who haven't picked them up yet. Judy Johnson noticed that her name was in the newsletter and received a black and white fat quarter. Treasury books were re-audited by Marla Bradberry, Karen Hawkins and Donna Petrick. The previous committee included a board member that was not permissible per the bylaws. The owner of *The Quilter's Workshop*, Sam Lamoreaux, is honoring the Plano guild each Friday following the guild meeting with a 10% discount. Service bars will be awarded in December 2009 for at least 30 hours of any volunteer time during 2009 that promotes the Plano guild activities. Members need to start counting their hours and turn the information in to the VP of Community Service. The bars will be attached to a special pin that will be available. A quilt related charm that can be attached to the bar will be given for 8 hours of quilt show volunteer time.

### COMMITTEE REPORTS

**Community Service:** Sheri Smith reported that \$183.37 was collected from the membership to buy items to put into the Christmas stockings. Most of the funds were spent to help fill 410 stockings for toddlers and teens. The agency voiced a need for plastic baby bathtubs and wash clothes. \$60.00 was spent on these items. The Parkland and VA hospitals give every newborn a stocking during December filling them with needy items. The 900 stockings we made that were not filled will be given to these hospitals. Karen Christoffer does a marvelous job with the Community Service sewing group getting quilt tops made. Two people who have recently contacted the Guild are giving a lot of fabric that can be pieced into quilt tops, so we have plenty of fabric. At the present time we have at least 100 tops that need to be quilted. During the months January through April we will have a contest for members taking a community service top, batting and backing home to be quilted. Every time a quilt is turned in to Community Service the quilter's name will be placed in a "hat." The quilt does not have to be bound. In May names from the hat will be drawn for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place awards. One of the awards will be a quilt kit by Alex Anderson called "Baskets of Romance." An article in the *Turning Point Newsletter*

from the *Rape Crisis Center* was read. It expressed gratitude for the generosity of the Guild in providing 491 quilts. *The Samaritan Inn* needs big quilts as does *My Friends Place* that will be opening soon.

**Programs:** The January meeting program will feature Linda Reynolds, a research librarian from Stephen F. Austin University. She will speak on the history of East Texas Quilts. The January workshop will be on beading taught by guild members. The cost is \$25.00 for the beading workshop and kit. Any money collected will be given to the Guild for future programming. If you sign up at least 35 days ahead of time for a workshop you will get a \$5.00 reduction in workshop cost. The February program will be Sara Moe speaking on curved piecing. She also designs fabric. Her workshop, originally scheduled for the 20th and 21st, will be rescheduled at a more convenient time for members who are also attending the guild's retreat. *The Plano Art Center* is now presenting *Quilt Mania*.

**Membership:** Helen Wilems and Terri Mendelow announced that there were 51 members present as well as 3 guests (Mary Beal, Sanda Staggs and Susan Hudspeth). Amanda Dierling is a new member having just moved from Pennsylvania. On February 1<sup>st</sup>, 2009 the guild will host a New Member Tea. The invitation will include Joan Stevenson's email and phone number to RSVP. Door prizes were awarded from *Quilt Asylum*, *Quilt Country*, *Quilters Connection*, *The Old Craft Store*, *Suzy's Quilt Shop* and an anonymous donor.

**Retreat 2009:** Terri Anderman urged everyone to get her retreat enrollment information to her by January 10, 2009. How to email the enrollment is on the form.

**Quilt Plano 2009 Show:** Kemberly Wilshire reminded members that they need to complete the quilts they intend to enter in the show. The registration form for this will be available in February or March. There is going to be a focus on community service at this show. Information regarding the concept is forthcoming. Germaine Reconnu told us that she now has about 7 purses and 7 mini quilts for the show auction and we need many more of each.

**Fat Quarter Lotto and Block of the Month:** Marla Bradberry and Diane deFreitas have postponed these activities to next month. The categories for December fat quarters were "batiks," "black and white" and "anything goes." Block of the Month will be available in the newsletter.

**Show and Tell:** Since the program for the evening was on T-shirt quilts the emphasis of quilts shown was various quilts made from T-shirts.

The meeting was adjourned at 7:50 for the program.

## **NEW SERVICE AWARDS - Donna Petrick**

You deserve a reward for all the time you spend helping the guild accomplish its goals. I have been thinking about this for sometime and Kemberly Wilshire was thinking along the same line for volunteer time at the quilt show. So the board has come up with the following plan. I talked about it at the December meeting and will again in January.

The guild will award a service bar with the year on it each year that you serve 30 hours in volunteer time for the guild at no cost to the member. That includes community service sewing, selling raffle tickets, taking the raffle quilt to various places, working the events the guild has, doing lectures/presentations at various groups about quilting, etc.... anything other than just attending the monthly meetings. Then each show year, the guild will have a charm attachment for working 8 hours for the show. The numbers of hours required for the award are subject to change in future years at the boards' discretion.

The hours will accumulate from January of each year until the November guild meeting only and will not carry

**COMMUNITY SERVICE - Sheri Smith**

Our year ended with a successful delivery of Christmas stockings to Parkland Hospital. Two volunteers were waiting for us at valet parking and we unloaded two carloads of items for them. One of the hospital volunteers thanked us profusely and stated that they really look forward to our contributions. It doesn't get much better than that. LaDawn had collected \$183.37 at our guild meetings and spent the majority of the money on items for the toddlers and teens stockings. She also spent \$60.00 on 3 plastic baby bath tubs, wash cloths and soaps. In addition to our filled stockings we donated 900 empty stockings. Parkland stated that they deliver 100 babies a day, so this donation will be for 9 days during the holidays. Many, many thanks to all that participated over the year making these stockings. This month we also delivered 23 quilts to the Children's Advocacy Center and 10 to the Rape Crisis Center.

**Elise SansSouci** is the recipient of the January black and white fat quarter if she will speak to President Donna Petrick before or during the business meeting.

The next Community Service Sew Day will be held at Plano Sewing Center on January 13, 2009. Again it will be an open house, so pick your time between 9:30 and 4:00, but please let Karen Christoffer know when you will be there.

In January we are beginning a quilt reduction contest. For every quilted top you turn in your name will go into the basket. The contest will run through April and at the May guild meeting we will draw 3 names. A third place prize, a second place prize and the grand prize will be a black and white kit by Alex Anderson, called "Never Enough Romance." The quilt size is 65 1/2 inch square. So get those tops that need to be quilted at the Community Service table and start quilting.

### Discussion:

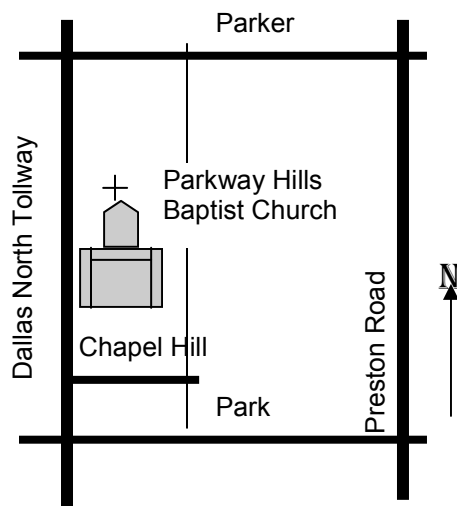
- There will be board changes for next year's officers. There will also be committee chair openings.

**BLOCK OF THE MONTH - January - Diane deFreitas and the Knotty Girls Small Group**

**Batik Basket Bonanza—Basket #7**

All the blocks this year will be pieced baskets made of a good quality batik and white-on-white as the background. All blocks will be 10 inches finished and 10 1/2 inches unfinished. Be careful with your 1/4 inch seams and your pressing so that the blocks that are won are uniform in size. Questions? Call Brooks Wilson or Diane de-Freitas

Cutting instructions:

*Basket* (batik—your color choice)

D—cut 1 square 6 7/8" - cut in half on diagonal

F—cut 4 squares 2 7/8"

H—cut 1 square 2 7/8" - cut in half on diagonal

*Background* (white-on-white)

A—cut 2 rectangles 2 1/2" X 6 1/2"

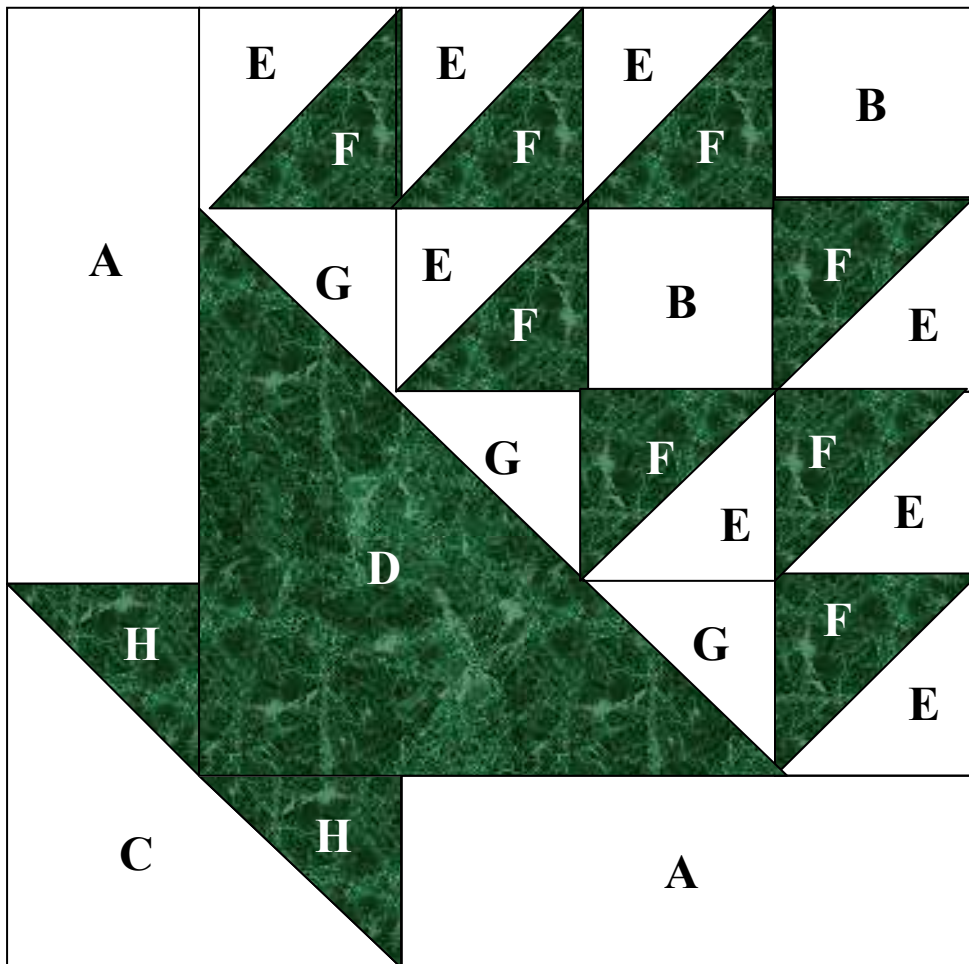
B—cut 2 squares 2 1/2" X 2 1/2"

C—1 square 4 7/8" - cut in half on diagonal

E—cut 4 squares 2 7/8" - cut in half on diagonal

G—cut 2 squares 2 7/8" - cut in half on diagonal

To make E/F half-square triangles: layer E + F squares, right sides together. On back of lighter square, draw a diagonal line. Stitch a scant 1/4" on both sides of drawn line. Cut in half on drawn line. This will yield 2 half-square triangles (or you may use triangle paper or any other technique to yield 8 total half-square triangles that are 2" finished). Follow the diagram below to assemble the block.
