## PRESIDENT'S CHALLENGE TO BENEFIT SAMARITAN INN—PAM WALSH

Samaritan Inn is the only homeless shelter in Collin County. In 2014, the Inn served 624 residents: 218 of them were children.

Located in McKinney, the Inn provides a nocost, safe and clean place to live while the residents regain their dignity and independence. Living areas for men, women, and families are separate. The facility includes a dining room, playroom, computer lab, classrooms, a chapel, a playground and a kennel for residents' pets. The Inn serves 3 meals daily, provides personal hygiene products, free laundry, haircuts, over-the -counter medicines and vouchers for other services, including day care and transportation. Residents attend a variety of classes and meet one-on-one with their professional caseworker to develop an individualized action plan and goals for their success. Residents who gain full-time employment, complete Financial Peace University, and achieve their savings goals can apply for transitional housing, which supplies a fully-furnished apartment with a stair-step to help readjust to market rates and independent living responsibilities.

The Quilt Guilds of Collin County have received a special request from Kiddo Comforts on behalf of Samaritan Inn for 150 quilts for the children that they serve. Each quilt will be given to a child to be used while living at the facility. The quilt belongs to that child to take with him or her when the family leaves Samaritan Inn. Kiddo Comforts, a non-profit that focuses on children in distress, will deliver each quilt marked with the child's name, after receiving requests from the caseworkers for new resident children.

The request is for quilts appropriate for boys or for girls ranging in age from one to eighteen. The quilt size should be approximately 40" by 60" and it should be accompanied by a coordinating pillowcase.

As announced at the October Guild meeting, participants will be included in a drawing at the end of the challenge on March 31<sup>st</sup> to win one of three customized bags.

Owner Patty Kopeck manages to offer something for everyone in her 1200 square foot shop. Sew Let's Quilt It underwent an enlargement renovation last year thus allowing space for additional merchandise. She stocks approximately 1,000 bolts of fabric that include our favorite 100% cottons, pre-cuts, batiks, wide backings, flannel and Minkee/Cuddles. There are also plenty of notions, including Superior threads, Creative Grid Rulers, books, patterns, and even purse and bag accessories. This is truly a one stop shop. You can get all of your fabrics. patterns, and notions then when your top is finished you can get instruction on how to load and operate a longarm guilting machine and rent time to guilt your own guilt. Patty also offers Longarm Quilting Service and Memory Quilt/T-Shirt Quilt Service. (Don't tell anyone I said so, but I find great fabrics in the sale area...I scored over 30 yards for Community Service on my trip to interview Patti.)

One of the things I like best about this store is the fantastic level of Customer Service. Patty describes her store as, "small but effective". She and her staff "always try to be helpful", they always "want the customer to be happy with the process of what they are doing".

For a relaxed quilting experience, try the Wednesdays or 3<sup>rd</sup> Saturday Sit & Sews. This is a fun time for sharing the quilt making experience



with friends. No Reservations are required, just show up and have fun.

Farm Girl Vintage, by Lori Holt, is a new block of the month that will be starting soon. Your monthly kit will contain enough fabric to complete one large or two small blocks. You can save your scraps and make even more blocks. I love seeing the gorgeous quilts you all make for community service! Those that receive them are so appreciative! I get the best reactions from the rape crisis center. I deliver to the same person each time, (which is rarely the case with our other organizations), and she always tells me how beautiful they are and what a difference they make for the victims who receive them. This last month when I stopped to drop off 16 quilts and 7 afghans, she told me they had run out of our quilts, and the nurses at the hospital were calling and asking when they would get more! Never doubt that your efforts are appreciated!

If you want to know about our different charities, the information is all under the community service tab on the website!

A couple of requests: our new Stocking Project chair has worked really hard to get a bunch of kits ready for sewing. I hope you were able to pick up a few at the meeting. If not, I'm sure you can call Lizzie Bailey and make arrangements to pick some up! We need to have them finished and turned in at the November meeting, so that Lizzie can get them to Soldier's Angels before December. Also, that would be the time to bring any small, unopened toiletries, gift cards, phone cards, socks, etc to help with "stuffing." Anything that can fit in a stocking and would be appreciated by our returning veterans.

Also, twice a year we donate a few small quilts and baby supplies to the PISD Student Parent program for their Christmas and graduation parties. At these parties, the students can "purchase" baby supplies with points they have earned throughout the year. If you wish to donate any baby supplies, please bring them to the November meeting. These can be anything from car seats to small new toys.

So, in conclusion, for the November meeting, please bring: any quilts or community service kits you have finished, completed stockings and any stocking stuffers, and any baby supplies you wish to donate!

As always, thank you so much for the work you do for our community. If Christmas time makes you sad, we have a saying in our house: "Forget yourself, and go to work!" "Work" meaning service to others. You will be amazed at how quickly your Christmastime blues turn into real joy!

#### Using the Website—Lynne Fritsche

There is a wealth of information on our website, and I hope you will explore it. Most of the content there does not require you to log in. However, accessing the membership directory and recording your volunteer hours both require that you log in as a member. I know a number of people have had trouble with this process, so here is a step-by-step procedure to get you started.

#### How to log in to the website:

- ♦ Go to <u>www.qgplano.org</u>
- On the left side of the page, enter your user id and password, then click Login.
  - If you are a new member, your user id and password were emailed to you when you ioined.
  - If you joined the guild before August 2014, you probably did not receive an email. Your user id is the first letter of your first name, followed by your last name. (For example, the user id for Jane Doe is jdoe.) Your password is <u>password</u>, unless you have logged on before and changed the password.
- If you get an error message and cannot log in, you will see a page with two boxes. If you have forgotten your id or password, use the second box to enter your email address. The system will automatically send you an email telling you your

- current ID and password, and it will show you a page saying "Your message has been sent." If you do not see the page with that message, you may have entered an incorrect email address.
- If you still cannot log in, send an email to webmaster@qqplano.org for help.
- Once you have successfully logged in, please change your password whatever you want it to be, something that you can remember (but not password!).

#### **How to change your password:**

- ♦ Log in to the website.
- ♦ Go to the membership roster (on the Members tab).
- ♦ Click on your name
- ♦ Click on Change Information
- Replace the black dots in the Password box with your new password
- Review the other information on the page and change anything that is not correct (address, phone, etc.).
- Olick on Update Record (near the bottom). You're done!

## QUILTING TIPS & TUTS—EASY QUILT BORDERS ALSO KNOWN AS: A FLAT QUILT IS A HAPPY QUILT!—PAM WINGATE

Welcome to the very first of our Quilting Tips & Tuts! This will be a regularly occurring feature in the newsletter but you will also be able to find more detailed versions of the Tips & Tuts posted on the Quilters Guild of Plano website under 'How To' on the Resources Tab for easy referral. This month provides an easy way to apply borders and keep your quilt flat & happy!

A common problem with borders is when they have stretched larger than the pieced quilt top, creating a "ruffled" look and extra fullness. This happens when borders are added to a top without measuring, and are sewed to the top, then trimmed to length. This problem gets worse the more borders you have on a quilt! Here's a quick step-by-step method that works with 'l' borders where the vertical borders are added first, followed by the top and bottom horizontal borders or 'H' borders where the horizontal borders are sewn first.

Step 1: Lay your quilt center on a flat surface, usually the floor, smoothing without stretching. Lay 2 lengths of prepared borders across the quilt vertical, keeping the 2 layers together.

**Step 2:** Slide a cutting mat under the fabric and cut slightly off the

edge of the quilt (do not cut the quilt!) using the ruler to make a right angle cut off the border. Carefully

slide out the mat and repeat on the other side of the guilt.

Step 3: This step is important! Pin the border strips to the vertical sides of the quilt, matching the ends and centers, and easing any fullness, if necessary. Sew using a 1/4" seam and press seam allowances towards the border.



Step 4: Lay the quilt on a flat surface again, smoothing without stretching. Lay the prepared border across the horizontal middle of the quilt top and repeat Step 2, cutting the border to the width of the quilt top which includes the just-added borders. Again, do not cut the quilt when

trimming the border, trim slightly off the edge.

Repeat **Step 3 -** pin and sew borders to top and bottom horizontals and press.

All done!

Repeat steps 1-4 for each border that is applied.

Easy peasy!

Pam asked if there was any other business. There was none, meeting was adjourned at 7:30 p.m.




### TEXAS ASSOCIATION OF QUILT GUILDS—SHERRY WORLEY


Is there anyone near 190/Jupiter or Plano Centre who can provide access to a piano for RaNae Merrill? She used to play the piano

#### OCTOBER BOARD MEETING MINUTES—PAM CARROLL

The meeting was called to order at 6:30 p.m. by president, Pam Walsh. Those also in attendance were Pam Carroll, Carol Long, LaDawn Dalley, Tina Connolly, Lynne Fritsche, Mary Shannon, Pat Wiant, Pam Wingate, and Peggy Burrell. The president asked if there were any changes to the September minutes which were previously submitted by email. No changes were noted, and LaDawn moved that they be approved. The motion was seconded by Pat, the minutes were approved as submitted.

Pam discussed her work on the development of a one page, "Welcome to New Members" handout intended as an overview to easily acquaint our new members with the operations of the Guild. She will make revisions and have them available at the Guild meeting. She then asked the Board if the current time and place of the Board meetings were acceptable to all. All members concurred, so time and place will stand as is for the present.

**Treasurer:** Carol Long had previously submitted the treasurer's report and the proposed budget for fiscal year 2015-16 via email to the Board. She stated that she needs to have budget revisions from each committee back by October 16<sup>th</sup>. Discussion followed regarding various budgeted items. Carol then discussed procedures for disbursement requests and deposits. She handed out copies of the forms to be used to all board members.

Committee Reports were as follows:

<u>Sunshine& Shadows</u>: Pat Wiant discussed ways we might recognize "Sunshines"; she said she gets mostly "Shadows." She will consider if/how to implement the things that were discussed.

<u>Membership</u>: Under Hospitality, Mary Shannon discussed new member bags, which will be continued; she suggested some ways we might welcome new members including badges for new members and/or having them be greeted by a "hospitality" member at the meetings. Since the new logo has been released, the Board discussed whether to continue to sell pins having the old logo. Pam suggested we go on and sell them for \$1.

Programs: Possible options for big name speakers were brought up. Pam stated she would like to see a big name in June and some other months also since we have the money to spend. Since several names were offered, Peggy Burrell said the Program Committee would consider them. It was mentioned that the members seem to want to see technique classes more than project classes, as it is hard to finish a project in the time

allotted to a workshop.

Community Service: LaDawn Dalley stated that she had delivered 44 quilts and 7 afghans to our charities last month. She was approached by a member asking for donations for Hospice. This was discussed, but it was decided that we have our plate full already with our existing charities and the new challenge for Samaritan Inn.

LaDawn said she had made some changes to the donation letter; Lynne will send the secretary a finalized copy for the document file.

The Samaritan Inn challenge was discussed. It was made clear that the quilt size must be 40" x 60". Pam had a conversation with Samaritan Inn regarding their specific needs such as the pillow cases, and she will discuss the details at the guild meeting.

There are 250 finished tops which need to be quilted. This will be featured in the next newsletter. Options were discussed regarding how to get these done.

<u>Education</u>: Pam Wingate said she has six junior quilters signed up for the new class. Since no one volunteered to teach it, she will do it. She discussed the program. She has some people signed up for shifts at the Int'l Quilt Festival in Plano. She will ask again at the Guild meeting for more.

<u>Guild Activities</u>: Nothing new was reported; the change of retreat location was reported in the newsletter.

Media: Lynne Fritsche discussed the website and some of the problems members have had accessing it. She told the correct way to gain access after the new website was installed. If committee chairs need information on the site to be edited, Lynne said to contact her to do the update. Since the website allows for it, she has set up email addresses in the site so information comes to board members without their personal email addresses being shown on the site. This protects personal emails from being posted and seen by anyone visiting the site. She requested that we use these addresses, and she provided a list for the Board to use.

It was announced that Sherry Worley will write a feature article each month for the newsletter about local shops with priority given to those who paid for ads in the show program. Discussion on ideas, various topics, and how to present them followed.
