Deb will be giving two lectures with trunk shows at Rally Day,

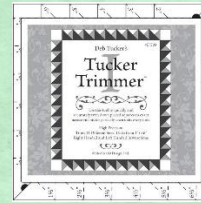
- The morning lecture is: "Higher Success, Less Stress"

Deb has a very straight forward approach that is methodical and logical. How wonderful that we here in north Texas will be having the opportunity to learn directly from Deb. Deb has been nominated for "Teacher of the Year" by Professional Machine Quilter Magazine.

Her techniques and rulers are incredible to use. Each ruler has multiple lines /marks by which to line up your block, assuring that the entire block comes out correct, you'll get true ¼ inch seam allowance to get sharp points.



The rulers have registration lines in multiple places so you can make sure your 45-degree angles are at 45 degrees and perpendicular seam lines are at 90 degrees. You won't want to miss this chance to learn from Deb herself!!

## Gun Barrel Quilt Guild – 4-H Project

Several years ago, I started thinking about our (Gun Barrel Quilters Guild) Mission Statement. The statement says that we are to “preserve the heritage of quilting”. The retired teacher in me says that we need to do that by teaching kids to quilt.

So off I went to get started. Several members of our guild tried to contact county extension agents about teaching 4-H kids to quilt. It took us a little while because both counties near us were getting new extension agents. We started planning and offered a class to our first group of 4-H kids the summer of 2017. What a success!

Our class has 6 girls, ages about 9 to 14, including a foreign exchange student from Japan. The class includes fabric selection, proper use and care of tools and notions, quality in fabrics, and how to operate and care for sewing machines. A local quilt store, the Needle Niche in Athens, agreed to help the kids select fabric and offered them a discount on the fabric. So we were set.

We met several times a week throughout the summer. The kids selected their patterns and fabric, cut all the pieces, made the blocks, and assembled the blocks. They were so proud of their quilt tops. Some of the kids elected to have their quilt tops quilted by people with long arm machines. Others wanted to wait until they learned to quilt and finish the quilts themselves.

I continued to meet with the kids periodically. In November, six other guild members and I met with the kids for a “fabric play day.” The kids had five holiday projects to complete including a quilted hot pad, a yo-yo Christmas tree, a Christmas birdhouse wall hanging, and several other holiday projects. At the end of the day, happy, but exhausted kids, left with their projects.

I wanted to expand on my idea for this adventure, but it does cost money. So I applied for a grant from the Texas Association of Quilt Guilds (TAQG). Thankfully, we were awarded a \$1,000

grant. We are so excited. I am currently working with Walmart in Gun Barrel City to purchase sewing machines at a discount. The Mabank fire station allows us to use their community room free of charge. Several husbands of guild members are mulling over plans to build a locking storage cabinet.

The 4-H kids, who our guild members now refer to as “our 4-H kids”, will start working on new projects this summer. We plan to offer a summer camp for children ages 9-12 this summer. Our guild is planning on meeting with administrators from several school districts to see if they will allow us to volunteer in their Family Consumer Science classes to teach their students to make quilts, with the goal being to complete their quilts in time to enter them in our annual quilt show in April 2019.

And so our mission continues, with our goal being to continue to promote the art and heritage of quilting. We hope that people new to quilting will come to love it as much as we do.

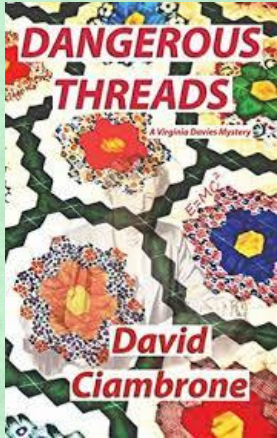

## **Dangerous Threads (A Virginia Davies Mystery)**

**2014 by Author: David Ciambrone**

My wife, Melissa, gave me this book after the presentation by its author at the LSHQG meeting in April. I looked it up online and saw that this book received mixed reviews on the GoodReads and Amazon.com websites. After reading the book myself, my wife asked if I would provide a short write up on my impression of this book.

Dangerous Threads is a Mystery Thriller, centered on the search for a 1933 World's Fair award winning quilt, named "The Unknown Star". The 1933 World's Fair Quilt contest was factually sponsored by Sears & Roebuck and this specific first place quilt was indeed later given to then First Lady, Mrs. Franklin D. Roosevelt. This quilt eventually disappeared and here the Dangerous Threads' story line continues. Albert Einstein, who had discovered a key to the Unified Theory of Physics, wanted his findings hidden away for future generations after he saw the development of the atom bomb. Einstein contacts his friend Mrs Roosevelt and they secreted the Unified Theory findings, within, the Unknown Star Quilt, and then the First Lady sent the quilt away to an unknown person or location for safekeeping. The plot is that decades later the US government as well as many nations and nation-state-actors, are diligently searching for this quilt and the possibly powerful secret hidden therein.

Virginia Davies a museum curator and quilter, and her husband, Dr Andy Clark an engineer and Phd, along with Virginia's close friend, Donna, are hired by the US government

to be attached to the Smithsonian's Central Security Service, and as such become US Federal Agents charged with searching for, locating the quilt and safeguarding the hidden knowledge. The author never explains how this adventurous trio has become singularly adept at employing SWAT and Special Forces capabilities, but non-the-less they turn the tables on street-gangs, foreign secret agents, and state-actor-hitmen, with regularity, showing little fear, and the willingness to dispatch cold, calculated, ruthless-violence on those seeking to harm them.

Other book reviewers have criticized the plot/concept - that a quilting museum curator and a Phd/engineer could tackle circumstances that would be challenging to "secret agents". However unlikely, better books and movies have successfully capitalized on just such an absurdity, such as: National Treasure (an archeologist & treasure-hunter); Culper Ring Series (an Archivist); Da Vinci Code (an art & religion symbologist); and in the Sigma Series (employing special force scientists, headquartered under the Smithsonian non-the less). These plots worked very well to the delight of many readers and movies goers. This book won't measure up to ones written by Baldacci, Grisham, or Clancy, but it offers fun, recreational reading wherein the trio's antics and misadventures are almost non-stop, and where weapons use and assaults paralleled the wacky sequences in movies like Bad Boys II and Lethal Weapon.

David Ciambrone's – Author's Comment Section, gives greater detail on the Quilt's history and pattern evolution over the decades, and unwraps what is "fact" and what is "fiction" in his book Dangerous Threads. Overall, I would give this book – 2.5 - 3 Stars (out of 5) since I really did enjoy the read. Besides, how many authors have actually centered one of their thrillers around the history of a REAL, internationally recognized, Award Winning quilt?

## TAQG: Record Keeping March 27, 2018

The information presented here is an abridged version of the material presented at the March 27, 2018 Special Interest Meeting. This material is presented for informational purposes only. We suggest you consult an attorney for legal advice.

### Raffles:

- Controlled by Texas Attorney General. Class A misdemeanor to conduct and a Class C misdemeanor to participate in an unauthorized Raffle
- What I call "Code light" is a synopsis of the statute by the AG office. <https://www.texasattorneygeneral.gov/cpd/charities-nonprofits-charitable-raffles>

- In general, a qualified organization is:
  - A nonprofit association organized primarily for religious purposes...;
  - A nonprofit volunteer emergency medical service...;
  - A nonprofit volunteer fire department...; or
  - A nonprofit organization that has existed for at least three preceding years and is exempt from federal income tax under Section 501(c), Internal Revenue Code; does not distribute any of its income to its members, officers or governing body; does not devote a substantial part of its activities to attempting to influence legislation; and does not participate in any political campaign.
- A qualified organization may offer any prize except money. "Money" is defined as coins, paper currency, or a negotiable instrument that represents and is readily convertible to coins or paper currency.
- Each raffle ticket must state: 1) the name of the organization conducting the raffle; 2) the address of the organization or of a named officer of the organization; 3) the ticket price; 4) a general description of each prize having a value of more than \$10; and 5) the date on which the raffle prize(s) will be awarded.
- A qualified organization may hold only two raffles per calendar year and only one raffle at a time.
- Raffle tickets may not be advertised statewide or through paid advertisements.
- No one may be compensated directly or indirectly for organizing or conducting a raffle or for selling raffle tickets.
- Proceeds from ticket sales must be used only for the charitable purposes of the qualified organization.

The IRS must also be considered when conducting a Raffle:

- "An exempt organization must report raffle prizes if (a) the amount paid reduced ... by the wager... is \$600 or more; and (b) the payout is at least 300 times the amount of the wager.... The example would be if your quilt has a value of \$601 or more and your ticket sells for \$1.00 you are required to file a W-2G for the winner who will pay tax on the amount.
- "A person receiving gambling winnings must furnish the exempt organization a statement on Form 5754 ... stating his or her identity and the identity of any others entitled to the winnings (and their shares of the winnings.)"
- "The organization must keep Form 5754 for four years...."
- "The exempt organization must file Forms W-2G with the IRS by the last day of February of the year after the year of the raffle..... The organization must also issue Forms W-2G to prize recipients by January 31 of the year after the year of the raffle."
- If the prize is less than \$5,000 the Guild is not responsible for withholding the required 25%.
- The organization must list the EIN (employer identification number) of the organization conducting the raffle on Forms W-2G, 1096, and 945....

### Source Codes

The definition of source code is the original document or drawing in its original format. Documents saved as a source code can always be updated while documents that have been saved in another format, PDF for example, cannot be easily updated.

**Example:** A guild creates a set of by-laws. It creates the document in Word then saves it as a PDF for publication. Years later, however, the bylaws may need to be updated. If all you have is your PDF, not the source code, it will be more difficult to make the needed changes.

With drawings, source code is even more important. Guilds all create logos and designs for pins. The source code will contain information on colors, fonts used, sizes, etc. Many times guilds will scan or use a image of the logo and over time the source code is lost.

**Example:** When the TAQG Logo was created the original drawing/ computer format was not passed along. Over the years John has had to scan and tweak the logo several times. Finally to make the image clearer, he redrew it. He spent a lot of time searching for matches to the original colors and font.

Source Code can also be thought of as the original or the authority. For that reason all of the IRS related information presented in this document is directly from research through the IRS. It is not sourced from a third party's interpretation.

### Record Retention and Storage

Records should be kept both as paper copies and in a digital form. It would be a good idea to keep more than one set of records. Should

something happen to destroy one set of records you would still have a backup. Many Guilds are opting to keep a set of records on a cloud based system such as Dropbox.com. Dropbox offers secure file -storage and sharing on a fee basis. It is easy for officers to upload documents and reports as well as store copies of documents. It is also easy when you have a change of board members to change who has access to the site. There are a lot of cloud storage services. You might also want to look at pcloud, Google Drive, box, and OneDrive. You can do an internet search on alternatives to Dropbox for more options. The following website has great information on storing and destroying digital records. However, you need to be aware that their recommended retention schedule does not agree with what I found on IRS sites.

As a precaution you may want to consider storing the permanently kept records in a safe deposit box for security and safety purposes.

Records kept for IRS compliance is in this section. You may also choose to keep extra records of historical value to your guild. Things that would fall under this category are newsletters, general meeting minutes, scrapbooks and anything else of historical significance to your group. Take note: Meeting minutes showing new board members are usually required when changing signature privileges on guild bank accounts.

### Compliance Record Keeping Guidelines for the IRS

Here, the word "assets" refers to property owned by the Guild. Each guild should have an inventory that is updated on a regular basis.

### ASSETS & LIABILITIES

Assets are the property, such as investments, buildings, and furniture that an organization owns and uses in its activities. Liabilities reflect the pecuniary obligations of the organization. A public charity must keep records to verify certain information about its assets and liabilities.

Records should show:

- when and how the asset was acquired
- whether any debt was used to acquire the asset
- documents that support mortgages, notes, loans
- or other forms of debt
- purchase price
- cost of any improvements
- deductions taken for depreciation, if any
- deductions taken for casualty losses, if any, such as losses resulting from fires or storms

- how the asset was used
- when and how the asset was disposed of
- selling price
- expenses of sale

### How Long Should Records be Kept?

Public charities must keep records for federal tax purposes for as long as they may be needed to document evidence of compliance with provisions of the Code. Generally, this means the organization must keep records that support an item of income or deduction on a return until the statute of limitations for that return runs. The statute of limitations has run out when the organization can no longer amend its return and the IRS can no longer assess additional tax. Generally, the statute of limitations runs three years after the date the return is due or filed, whichever is later. An organization may be required to retain records longer for other legal purposes, including state or local tax purposes.

### Record Retention Periods

Record retention periods vary depending on the types of records and returns.

- **Permanent Records** – Some records should be kept permanently. These include the application for recognition of tax-exempt status, the determination letter recognizing tax-exempt status, and organizing documents, such as articles of incorporation and by-laws, with amendments, as well as board minutes.
- **Employment Tax Records** – If an organization has employees, it must keep employment tax records for at least four years after the date the tax becomes due or is paid, whichever is later.
- **Records for Non-Tax Purposes** – When records are no longer needed for tax purposes, an organization should keep them until they are no longer needed for non-tax purposes. For example, a grantor, insurance company, creditor, or state agency may require that records be kept longer than the IRS requires

### Public Inspection and Disclosure

Because certain forms, by law, must be made publicly available by the IRS and the filer, do not include any personal identifying information, such as social security numbers not required by the IRS, on these forms.

### Exemption Application –

A public charity must make available for public inspection its exemption application, Form 1023, Application for Recognition of Exemption Under Section 501(c)(3) of the Internal Revenue Code, along with each of the following documents:

- all documents submitted with Form 1023;
- all documents the IRS requires the organization to submit in support of its application;

- and the exemption ruling letter issued by the IRS.

#### Annual Information Return –

Please refer to the document for return information. Rules differ depending on which 990 form you file.

#### Public Inspection and Disclosure Procedures –

A public charity may place reasonable restrictions on the time, place, and manner of in-person inspection and copying, and may charge a reasonable fee for providing copies. It can charge no more for the copies than the per page rate the IRS charges for providing copies. A tax-exempt organization does not have to comply with individual requests for copies if it makes the documents widely available. This can be done by posting the documents on a readily accessible Web site. For details on disclosure rules and procedures for 501(c)(3) organizations, see the (IRS Publication) **Life Cycle of a Public Charity** and the **instructions to Forms 990, 990-T and 1023** at [www.irs.gov/eo](http://www.irs.gov/eo).
